AMENDMENT TO THE DECLARATION OF

COVENANTS, CONDITIONS, AND RESTRICTIONS

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR ANNISTON is made this the 4th day of October, 2013, by the

Anniston Homeowners Association, Inc. hereinafter referred to as the "Association."

WITNESSETH THAT

WHEREAS, by the following instruments recorded in the Iredell County Registry, the Declarant, Anniston, LLC subjected Anniston Homeowners Association, Inc. (the "Property") to the Declaration of Covenants, Conditions, and Restrictions for Anniston (the "Declaration") and supplemental declarations to the same:

- c) Book 1785, Page 1854 on September 22, 2006;
- d) Book 1831, Page 1013 on March 13, 2007;

- f) Book 1883, Page 35 on September 12, 2007;
- g) Book 1902, Page 1663 on December 4, 2007;
- h) Book 1931, Page 1806 on April 8, 2008;
- i) Book 1959, Page 1148 on August 14, 2008; and
- i) Book 1964, Page 780 on September 12, 2008.

WHEREAS, the lots within the jurisdiction of the Association that are subject to this amendment include the following Plat Books and Pages, recorded with the Iredell County Register of Deeds:

WHEREAS, Article IX, Section 3 of the Declaration provides that the Declaration may be amended or modified at any time by a vote of no less than sixty-seven percent (67%) of all votes entitled to be cast by the Association members.

NOW THEREFORE, having obtained the required consent to amend the Declaration of Covenants, Conditions, and Restrictions for Anniston for those Plat Books and Pages shown above, the Association hereby makes the following modification to the Declaration:

Article VI, Section 25, Septic System Inspection and Septic Inspection and Repair Easement.

The Association shall cause all private Septic Systems located within the Property to be inspected no less than once every year or when otherwise required by law. Such inspections shall be conducted in order to confirm that each such system is properly functioning and is generally in compliance with any applicable laws, ordinances or governmental regulations. If an inspection reveals that a Septic System is not functioning properly, or is otherwise not in compliance with any applicable law, ordinance or regulations, the inspector shall notify the Owner, the Association and any other party or agency as required by law. The Owner shall be responsible for immediately repairing the Septic System at such Owner's sole cost and expense and providing the Association, within thirty (30) days, with proof of such repair. The Association shall be authorized to notify any applicable governmental or regulatory agencies or officials of the malfunctioning or noncompliance of any Septic System located within the Property.
